Stabling

No stall reservations will be accepted unless accompanied by a horse entry. All stall fees are absolutely **NON-REFUNDABLE, NO EXCEPTIONS**. We will do our best to re-sell a stall if we are given notice, but failing that, all stall charges are the responsibility of the person who reserved it. Stall fees are \$60.00 per day, shavings are \$11.00 per bag. Please see the attached stabling form or download it from our website. Trainer stall split sheets are also available. In order to avoid confusion, please include the name of your trainer/barn and your horse's name on the stall request form. Stalls are billed on a calendar day basis. If you book open schooling the day before show start and stay overnight, the charge for that night will be half. Due to the ongoing problem with shavings counts - please be advised that if your pre-ordered shavings are not in your stall when you arrive and you do not advise the office immediately there will be no refund. We cannot reimburse for pre-ordered shavings at the end of your show day. If you require shavings during the show day you must come to the office to receive an order slip...no shavings will be delivered without a slip signed by an office staff member

Ribbons and Prize money

Ribbons will be awarded to eighth place. All divisions will run if there are 3 or more than three (3) entries as of the closing date. With less than 4 and at the discretion of the show management entry fee will be adjusted and no prize money paid. Prize money to be allocated to the top four placings as follows:

TRILLIUM DIVISIONS – RULES AND REGULATIONS

**PLEASE READ THESE REQUIREMENTS CAREFULLY
THEY WILL BE STRICTLY UPHELD**

SECTION 1 – MEMBERSHIPS – IMPORTANT CHANGES TO RULES BELOW**

1. Any rider(s) entering bronze/silver classes or divisions at this horse show, and any person or group listed as the owner(s) in the EQUESTRIAN CANADA Competition Horse recording of any horse or pony entered in any class or division at this horse show MUST be current members in good standing of the Ontario Equestrian (OE) and must supply original or photocopy of their 2026 OE membership card at the show, whether or not they intend to collect points toward Central East Zone year-end awards or qualify for the Trillium Championships.
2. Any rider(s) entering bronze/silver classes or divisions at the horse show, and any person or group **listed as the owner(s) in the EQUESTRIAN CANADA Competition Horse recording of any horse or pony** entered in any class or division at this horse show MUST be current members in good standing of the Trillium Hunter Jumper Association (THJA) in order to have prize winnings at this horse show count for points towards qualifying for the Trillium Championships and Central East Zone year end awards. **THIS INCLUDES THE OWNERS OF LEASED HORSES UNLESS THE LEASE IS OFFICIALLY REGISTERED WITH EC.**
3. All riders and owners of horses or ponies entered in the bronze/silver divisions/classes at this horse show require current EQUESTRIAN CANADA sport licenses in order to have prize winnings count for points towards qualifying for the Trillium Championships and Central East Zone year-end awards. A copy or the original cards must be presented at the horse show.
4. Fully updated EQUESTRIAN CANADA Horse recordings and current Sport Licenses are required for horses and ponies competing in all Trillium (Silver) divisions except Hack. In competitions that require horse recording numbers the prize list must state that all canadian entries are required to hold an EC horse recording and have paid the EC horse recording annual activation fee to compete. Foreign entries must sign an affidavit. **Any competitors arriving at the show without proof of the appropriate memberships/horse recordings for their divisions will be ineligible to compete, or MUST PURCHASE A TEMPORARY LICENSE AND/OR HORSE RECORDING.** These are available for purchase directly through the competitors MyEC portal. Competitions are not to administer these purchases directly. All competitors/owners/coaches who do not have the appropriate level of license must login to purchase the upgrade before competing at the event. Please note that allowing individuals to participate without a proper sport license may result in fines for both the event and the competitor/owner/coach.

SECTION 2 – ADMINISTRATION

5. Entries must be received on or before the closing date to avoid post entry fees. Closing date is the SUNDAY BEFORE SHOW DATE, 8:00pm. Entries received after Sunday and prior to Wednesday, 8:00pm before the show date will be assessed a \$30.00 fee. ENTRIES RECEIVED AFTER WEDNESDAY BEFORE SHOW date will be assessed a \$50.00 fee. It is the responsibility of the entrant to provide proof of timely entry submission should there be a disagreement regarding time of entry. All entries will be marked with date and time of reception.
6. **Refunds: Administration and stall fees are not refundable. NO EXCEPTIONS.** Entry fees will be returned if cancelled in the show office in writing 24 hours prior to the

first class entered with proper medical documentation. Once a horse has entered the show grounds, there will be no refund unless authorized by the show committee. Scratch Fees** No telephone entries or scratches can be accepted. Scratched entries providing notification 24 hours in advance without a veterinary certificate will be assessed a \$30.00 scratch fee and the administration fees, class/division fees will be waived. All unpaid fees will be considered an outstanding account until paid in full. Any classes/divisions entered but not completed will be charged. There will be no refund for classes scratched on the day of competition for any reason. You may change from one class and replace by another or change from one division to another at no additional charge.

7. No numbers will be issued without a signed open cheque, or sufficient cash left to cover all charges and fees incurred by the exhibitor. Please make cheques payable to Joker's Hill Horse Shows. No numbers will be issued to any horse or rider for whom an entry form has not been fully completed. **NO ENTRY WILL BE ACCEPTED FOR EXHIBITORS NOT IN GOOD STANDING.** All outstanding accounts must be paid in full before an entry can be accepted and processed. All outstanding accounts will also be forwarded to other show managers for collection at their competitions.

8. All **NO SHOW** entries will be charged full entry fees and all other applicable fees. All accounts must be settled prior to the next show, otherwise entries will be denied, and no points will be awarded. Please note any outstanding accounts at year end will not be eligible to receive year-end awards.

9. A \$50.00 charge will be added to all accounts paid with cheques that are returned from the bank for any reason.

10. Show Management reserves the right to change or amend show scheduling up to one (1) hour prior to the designated class.

11. Under NO circumstances will a PHONED IN entry, stabling request, or cancellation be accepted.

12. **NO CELL PHONE PICTURES OF ENTRIES WILL BE ACCEPTED.**

13. Entries sent incomplete ie. Missing membership numbers, no classes selected, missing contact information, etc. will be subject to a \$20.00 fee.**** **All requested information on the entry form MUST be provided ACCURATELY to avoid this fee.**

SECTION 3 – GENERAL

14. Current EQUESTRIAN CANADA rules will govern all classes. Every class herein is covered by the rules and specifications of the current rules of EC and will be held and judged in accordance with the EC rule book. (A602.2

15. To compete in the under-saddle class, the horse must complete at least one course over fences.

16. Any and all dogs MUST BE LEASHED at the show.

17. Protests, if any, must be made in writing and must be in the hands of the secretary within 48 hours of completion of the class concerned. No protest will be considered unless accompanied by a deposit of \$50.00 that shall be forfeited to the committee if said protests are not sustained. Protesting an animal's height carries a \$100.00 cash deposit.

NOTE: Protests are usually made through the steward of the horse show. Also available at the horse show office are *Exhibitor Report Forms*. These require no cash deposit and may be submitted to the show office, the steward or sent directly to OE.

18. In the event of a fall of horse and/or rider, the competitor must leave the ring dismounted.

19. Proper show attire, including jackets, is required for all divisions and classes, including all jumper divisions and judged warm-up classes, unless excused by judge or show management.

20. Jumper classes, unless otherwise indicated in the Horse Show Prize List and Show Program, will be run under Article 238 AM5. **The use of draw reins is not permitted.**
21. Competitors must be junior or amateur in the Medal Classes.
22. Approved headgear: All competitors must wear proper fitting, approved protective headgear, with the safety harness correctly secured, at all times while mounted on competition or event grounds. Approved headgear meets the ASTM (American Society for Testing Materials) standards and displays the SEI (Safety Equipment Institute) seal. The British standard, BSI is also acceptable.
23. Management reserves the right to limit or close the entries of any classes or divisions in an effort to adhere to the timetable.
24. Any horse entered in any class at a competition may be selected for equine medication control testing while at the event location. (A602.5)
25. All entry forms must be signed by the competitor if they are an adult, and must have a parent or guardian signature for juniors. **COACHES/TRAINERS WHO SIGN FOR PARENT/GUARDIAN ARE ASSUMING ALL RISKS/WAIVERS FOR SAID PARENT/GUARDIAN AND THE JUNIOR COMPETITOR.** No competitor will be allowed to show without the required signature and will be liable for administration fees and scratch fees.
26. Hors Concours will not be permitted.
27. Any athlete an EC sanctioned competition may be selected for human anti-doping as outlined in the Canadian Anti-Doping Program (CADP) and administered by Sport Integrity Canada. Please see EC General Regulations Section A - Appendix A1, Policy on Human Medications for details.

RULES OF CONDUCT: Due to recent complaints and comments, we would like to take this opportunity to remind all trainers/coaches/parents/friends about the proper code of conduct with respect to ringside behaviour. It is inappropriate to shout instructions to or critique a rider as they are focusing on their required course or test. Providing some guidance in a normal speaking voice when the rider is very near the ingate would be acceptable however shouting instructions in a loud manner the whole time the rider is in the ring is very distracting to everyone in the vicinity (INCLUDING the judge) and the rider is unlikely to be able to hear the instruction anyway. This is also against Equestrian Canada's rules of conduct. Please be considerate to all of the show attendees and limit the ringside coaching to appropriate levels.

This division is geared toward riders new to the jumper ring who may wish to diverge from the hunter path early in their sport career. It is also available for adults wishing to develop pony jumpers. In theory, participants will have learned to ride at 325-350 m/m in a safe manner, with the ability to progress at the same event to riding in a jump-off at slightly increased speed.

If you jump the course or part of the course more than once you will be billed for a second round* . All horses wanting to school in the non-judged warm ups must be entered in the show and show numbers must be worn in the ring. Round will be monitored by Show Management. **Please be sure to indicate your class number on your entry form. Each of the judged schooling classes offer 2 rounds should you wish and time permits. Per Article A801, every entry at an EC-sanctioned competition shall constitute an agreement by the person responsible that the owner, lessee, trainer, manager, agent, coach, driver or rider and horse shall be subject to the EC constitution and all rules of EC and any additional rules set by the competition..."

"All horse entered in any class at a competition must have met the requirements of Article A519, Vaccinations. See Rules of Equestrian Canada, Section A, General Regulations, Article A519, Vaccinations." (A602.8)

When registering for EC sanctioned competitions, athletes must indicate the name of their coach on the entry form or specify that they are self coached. Coaches from other countries, must be in good-standing with their home federation and must declare/have proof of insurance. See Rules of Equestrian Canada, Section A, General Regulations, Article 102, Safe Sport Environments.

The EC Statement of principles:

- EQUESTRIAN CANADA STATEMENT OF PRINCIPLES – HORSE WELFARE 1. 2. 3. EC requires adherence to humane treatment of horses in all activities under its jurisdiction. All participants shall be bound by the Horse Welfare Code of Conduct. EC is committed to: a. upholding the welfare of the horse, regardless of monetary value, as a primary consideration in all activities; b. c. d. e. f. g. requiring that horses be treated with kindness, respect, and the compassion that they deserve, and that they never be subjected to maltreatment; ensuring that owners, trainers, and exhibitors and their agents exercise appropriate care and responsibility in the handling, treatment, and transportation of their horses, as well as horses placed in their care for any purpose; providing for the continuous wellbeing of the horse by encouraging routine inspection and consultation with health care professionals and competition officials to achieve the highest possible standards of nutrition, health, comfort, and safety; continuing to support scientific studies

on equine health and welfare; requiring owners, trainers, and exhibitors to know and follow their sanctioning organization's rules, and to work within industry regulations in all equestrian competitions; and, reviewing, revising, and developing competition rules and regulations that protect the welfare of the horse.

- Reservation regarding right to refuse entries (subject to championship rules limiting a competition's right to refuse entries).

A reminder that competition numbers must be worn and visible at all times

JOKERS HILL PHOTOGRAPHER POLICY

Jokers Hill Horse Shows has hired official photographers for each of our horse shows. These photographers work hard and spend long days out in all weather conditions in the hopes that the competitors will purchase their photos. They are not paid by show management, and are independent vendors who rely on the revenue from sales for their livelihoods.

In the past, there have been other photographers whom we have not hired also taking photos of competitors, and this takes away from the earning potential of the official photographer making it less likely that they would want to come back to our shows. This would be detrimental to all those who enjoy seeing their show photos but don't have access to/cannot afford a private photographer. For this reason we have decided to implement the following policy.

Any photographers or videographers with professional gear (which is defined as a full frame or mirrorless camera with a zoom lens) that are present at our competitions for the purpose of selling/giving their content to competitors/exhibitors will be **asked to stop taking pictures or asked to leave the premises**. This applies to both professional and amateur/junior photographers. The only exception to this rule is someone who is photographing their family member.

Private/Group/Barn Client Photographers/Videographers – You must have **permission from both the Official Photographer & Show Manager** to be able to attend the show as a private/group/barn client photographer/videographer. You may be declined access. If you are approved to attend the show as a private/group/barn photographer to take photos or videos of your client, your client must have pre-paid the official photographer for their full photo package before the show. If your client does not pre-pay for the package, you will not be approved for access.

If anyone is found photographing without permission or going against the rules above, they could be **banned from shooting for a period of 12 months**.

(Eligibility as per EC Rules)

In the 2026 EC Rule Book, the guide for junior ages is:

Junior "A" – a rider who is 15, 16, 17 on January 1st.

Junior "B" – a rider who is 12, 13, 14 on January 1st.

Junior "C" – a rider who is under 12 on January 1st.

Junior "A" Riders may not ride "B" or "C" ponies.

Junior "B" Riders may ride "A", "B", or "C" ponies.

Junior "C" Riders may ride "A", "B", or "C" ponies.

For show purposes, ponies are to be divided as follows:

"A" ponies – over 13.2 hands, but not to exceed 14.2 hands

"B" ponies – over 12.2 hands, but not to exceed 13.2 hands

"C" ponies – do not exceed 12.2 hands

- Trillium "A" Equitation Over Fences – Open to Large Pony Division riders with fences at 2'9"; Children's Division riders with fences at 3'; and Trillium Low/High division riders with fences at 3'3". In the event a rider competes in two different divisions requiring them to jump different heights, it will be their choice which height they will jump for the equitation over fences class. This choice needs to be indicated on the entry form.
- Trillium "B" and "C" Equitation Over Fences classes are open to small ponies with fences at 2'3", medium ponies with fences at 2'6", large ponies at 2'9" and horses at 3'.
- Adult Equitation – Adult equitation riders must be amateurs.
- A horse or pony ridden in an equitation class over fences, or in the jumper medal class may only be ridden in that class by one rider.
- In the event a rider competes in two different divisions requiring them to jump different heights, it will be their choice which height they will jump for the equitation over fences class. This choice needs to be indicated on the entry form.

Originally created in the image of the Jump Canada Medal, the Trillium Medal Class has evolved into a specialty class unique to the Trillium Circuit. Where a contradiction exists, these specifications supersede those of the Equestrian Canada Jump Canada Medal. These classes are open to Junior and Amateur riders only. Riders may walk the course. Eligibility as per individual hunter division specs for the particular medal.

First Phase - Over Fences: Figure eight course of not less than eight jumps. Class is judged in accordance with Article G1008 Class Routine Over Fences. No additional tests over fences are permitted.

Second Phase - On The Flat: At judge's discretion All contestants, or a maximum of ten shall be called back to perform at a walk, trot, and canter. From a maximum of four competitors, the judge may call for a minimum of two or more requirements from Article G1009 Tests (Equestrian Canada Rule Book Section G)

Scoring: Medal classes will be judged 60% over fences and 40% on the flat.

Tack & Equipment: All tack and equipment remain the same for both phases. Restrictions as per Article G1003 through G1005 (Equestrian Canada Rule Book Section G)

SILVER HUNTER DIVISIONS

Every pony entered in a pony division must have a valid Equestrian Canada pony measurement on file with Equestrian Canada. USEF pony measurement cards are also acceptable.

Small Pony Hunter Division: Fences 2'3"

Open to ponies not exceeding 12.2hh. Small pony riders must be 14 years of age and under as of January 1st of the competition year.

Medium Pony Hunter Division: Fences 2'6"

Open to ponies exceeding 12.2hh, but not exceeding 13.2hh. Medium pony riders must be 14 years of age and under as of January 1st of the competition year.

Large Pony Hunter Division: Fences 2'9"

Open to ponies exceeding 13.2hh, but not exceeding 14.2hh. Large pony riders must be 17 years of age and under as of January 1st of the competition year.

Modified Pony Hunter

Open to all ponies. Ponies will jump 3" below their regular pony hunter division height and distances will be adjusted according to pony size as per EC Rules G306.6.A. Age restrictions as per EC Rules G306.1. Pony/rider combinations may not cross enter into any other classes or divisions requiring them to jump with the exception of the Modified Pony Medal and their age respective equitation on the flat.

Small – Not to exceed 2'

Medium – Not to exceed 2'3"

Large – Not to exceed 2'6"

Short Stirrup Division: Fences not to exceed 21" (Verticals Only)

Open to "C" riders. Open to both horses and ponies, distances will not be adjusted. Riders may not enter any other classes except for "C" Equitation on the flat and My First Medal. Riders in the under saddle class must be short stirrup eligible.

Adult Amateur Divisions

- All adult amateurs must possess a current EC amateur card which is purchased annually.
- Adult amateurs may ride horses or large ponies. Please note that a pony ridden by an adult cannot be shown by a junior at the same competition (G201.2)

Adult Amateur Hunter: Fences 3'

As per Equestrian Canada Article G309. Riders in this division may cross enter to the Low Hunter and the Trillium Hunter Division at 3'3".

2'9" Adult Amateur Hunter Division: Fences 2'9"

A horse/rider combination may only cross enter into the hack division, the low/high open hunter division, the 2'9 adult medal, and adult equitation on the flat class. Riders may enter any other division or class at that show on another horse or pony. The horse may be shown in another class/division with another rider.

2'3"/2'6" Low High Adult Amateur Hunter Division

Open to adult amateur riders on horses and large ponies. A pony ridden by an adult cannot be shown by a junior at the same competition (G201.2). Distances will not be adjusted. Riders may compete in any eligible division with a height 2'6" and under. If also competing in the low/high open hunter division, they are only eligible to compete at the 2'6" (low) height. Horse/rider combinations are also permitted to show in the hack division, the 2'3"/2'6" Low High Adult Medal and adult equitation on the flat. Competitors may move up or down a height throughout the season but cannot change heights at an individual show.

Junior Divisions

- Open to horses ridden by juniors.

Children's Hunter: Fences 3'0"

As per Equestrian Canada Rules Article G307. Riders in this division may cross enter to the Low Hunter and the Trillium Hunter Division at 3'3".

2'9' Children's Hunter Division: Fences 2'9"

A horse/rider combination may only cross enter into the hack division, the low/high open hunter division, the 2'9 children's medal, and age-appropriate equitation on the flat class. Riders may enter any other division or class at that show on another horse or pony. The horse may be shown in another class/division with another rider.

2'3"/2'6" Low High Children's Hunter Division

Open to junior riders on horses and ponies. A pony ridden by an adult cannot be shown by a junior at the same competition (G201.2). Distances will not be adjusted. Riders may compete in any eligible division with a height 2'6 and under. If also competing in the low/high open hunter division, they are only eligible to compete at the 2'6 (low) height. Horse/rider combinations are also permitted to show in the hack division, age appropriate equitation on the flat and the 2'3"/2'6" Low High Children's Medal. Competitors may move up or down a height throughout the season but cannot change heights at an individual show.

Open Divisions

Low/High Open Hunter Division: Fences 2'6" and 2'9"

Open to all horses. No ponies are permitted. Horse/rider combinations may only cross enter to divisions requiring them to jump 2'9" and under, hack division, and their age-appropriate equitation on the flat. Competitors may move both up and down in heights between shows, but competitors may not change heights once the division has started. *Competitors must declare height on their Championship Show Entry Form.*

Note: 2'3"/2'6" Low High Adult Amateur Hunter and 2'3"/2'6" Low High Children's Hunter competitors may only jump at the 2'6" height in this division.

Low Hunter: Fences 3'

Open to all horses and riders.

Trillium Hunter – Low/High: Fences 3'3" and 3'6"

The low option of this division is open to all eligible riders. This division is not open to riders competing in the Children's 2'6" and 2'9" and Adult Amateur 2'6" and 2'9" Hunter Divisions. *The Trillium Hunter and Low Hunter Divisions may be combined at the 2026 Championships*

Hack Division

As per Equestrian Canada Chapter 12 and 13 – Classes Refer to Article G1301-1303.

TRILLIUM JUMPER MEDAL

This class is open to Junior and Amateur riders only and competitors will have the option to compete at either .9M or 1.0M. Competitors must declare their preferred height when making their entry. This class will have both a jumping phase and a flat phase with additional testing options at the judge's discretion. Jumping phase to be ridden first. Judged 60% over fences and 40% on the flat.

Tack & Equipment: All tack and equipment remain the same for both phases. Only running martingales used in the conventional manner are permitted. No standing martingales, draw reins

or restricted running martingales are permitted. Conservative coloured headgear (As per Article G1109) with no additional adornment. Stirrups are restricted as per Article G1109-G).

Jumping Phase – The jumping phase should be over an equitation type course of at least nine (9) fences. Fences will not exceed .90M or 1.0M in height with a spread not to exceed the height. The course must contain at least one double or triple combination with at least one spread fence. Other spread fences are required elsewhere on the course.

Flat Phase – At judge's discretion, All riders, or a maximum of 12 who complete the jumping phase, shall be called back to perform on the flat and demonstrate tests on the flat of the

judge's choosing. The top four (4) riders in the flat phase **may** then be asked to complete a short test including fences determined by the judge. When this test is being ridden, the riders will turn their backs so they cannot watch the other competitors.

SILVER JUMPER DIVISIONS

0.90M Jumper Division

Open to all horses and ponies. Maximum spread 1M. Run under Table A.

1.0M Jumper Division

Open to all horses and ponies. Maximum spread 1.10M. Run under Table A.

1.10M. – Trillium Jumper Division

Open to all horses. Maximum spread 1.20M. Run under Table A.

The 1.0M Jumper and 1.1 Jumper Divisions may be combined at the 2024 Championships

BRONZE BY THE THJA DIVISIONS

These divisions are sanctioned Bronze by Equestrian Canada

Junior/Amateur Cross Rail Hunter Division – 12”

Open to all horses and ponies, distances will not be adjusted. *Riders must be a junior or amateur as defined by Equine Canada rules.* Riders may only cross-enter into age-appropriate equitation on the flat and hack division (and any specialty class(es) at the Trillium Championships designed specifically for riders in this Division).

Junior/Amateur Long Stirrup Hunter Division – 21” (Verticals Only)

Open to junior riders 12 years of age and older on January 1st and adult amateur riders on horses and ponies. Adult Amateur riders may only show on a horse or large pony. A pony ridden by an adult cannot be shown by a junior at the same competition (G201.2). Distances will not be adjusted. Long stirrup riders may not enter any other classes except for age-appropriate equitation on the flat and hack division (and any specialty class(es) at the Trillium Championships designed specifically for riders in this Division).

2’3” Open Hunter Division – Fences 2’3”

Open to all horses and ponies, distances will not be adjusted.

0.75M Jumper Division

Open to all horses and ponies. Maximum spread .85m. Combinations are limited to a minimum of two strides -- vertical to vertical or oxer to vertical.

EC SPORT LICENSING 2025

SAFETY, INCLUSIVITY, & EXCELLENCE

Your guide to the latest updates for the competition season in Canada

IMPORTANT CHANGES have been implemented to enhance the safety and inclusivity of equestrian sport. Whether you're an athlete, parent, coach, official, or competition staff, your role is crucial in upholding these standards. Here's what you need to know:

SAFE SPORT TRAINING PREREQUISITE:

- The two free EC Safe Sport training modules must be completed before purchasing a Sport Licence. Check your training status on MyEC by clicking on the ECampus button.

DISCONTINUED TEMPORARY LICENCES AND TEMPORARY HORSE REGISTRATIONS:

- Temporary EC Sport Licences are now discontinued at competitions. All riders, owners, and coaches must possess an EC Sport Licence to participate in events. All horses must have a Horse Recording where level and division require.

AVAILABLE SHOW LEVEL UPGRADES:

- Explore higher-level competitions with temporary upgrades via your MyEC Portal. Note: National Rankings Points are not tabulated for upgraded results.

COACH STATUS REQUIREMENTS:

- All coaches at EC-sanctioned events require EC Licensed Coach Status. For upgrading from Registered to Licensed Status, coaches can apply for a Temporary Coach Status (TCS) to fulfill the requirement for each event.
- New for 2025: A TCS may be purchased conveniently online via the MyEC Portal only. Each TCS is valid for a single event.

EMPOWERING SELF-COACHED ATHLETES:

- Athletes without a coach on-site can declare themselves as self-coached by providing their name and EC Sport Licence number on their entry form. Coaches that are not present at the event with the athlete are not to be listed on the entry form.

“ When registering for EC sanctioned competitions, athletes must indicate the name of their coach on the entry form or specify that they are self-coached. Coaches from other countries, must be in good-standing with their home federation and must declare/have proof of insurance. See Rules of Equestrian Canada, Section A, General Regulations, Article 102, Safe Sport Environments. ”
